New Legislation



Public Records Act

- Senate Bill 400 Law Enforcement Agencies May, but are Not Required to, Release Statements Announcing Terminations of Police and Custody Officers
 - Penal Code Section 832.7(b)(13)



Workplace Violence Prevention

- SB 553 Employers Must Implement and Train Employees on a Workplace Violence Prevention Plan by July 1, 2024
 - Labor Code Section 6401.7 & 6401.9 (Effective 1/1/24, compliance required 7/1/24)



Employee Discrimination & Discipline



Discrimination – Liability

- The California Supreme Court Significantly Expands the Liability of an Employer's Agents
 - Raines v. U.S. Healthworks (8/21/23) 15 Cal.5th 268



Discrimination – Sanctions

- Terminating Sanctions Were Proper in an Employment Discrimination Case Where Ample Circumstantial Evidence Showed That The Plaintiff Deleted and Hid Text Messages With Witnesses, Intentionally Spoliating Electronic Evidence
 - Jones v. Riot Hospitality Group LLC (9th Cir. 2024) 95 F.4th 730

Hostile Work Environment

- University Had a Legitimate Reason to Terminate a Department Director When the Director Harassed and Retaliated Against Other Department Employees, Creating a Hostile Work Environment
 - Martin v. Board of Trustees of California State University (11/14/2023) 97 Cal.App.5th 149



Discipline

- Detention Officer's Disciplinary Appeal was Premature Because the Trial Court's Order That the Personnel Board Reconsider its Findings was Not a "Final Appealable Judgment"
 - Jackson v. Board of Civil Service Commissioners of City of Los Angeles (2/8/2024) 99 Cal.App.5th 648



Workers Compensation & Retirement



Workers Compensation

- City Firefighter Could Not Sue City for Negligence Because Workers Compensation is the Exclusive Remedy for Employees
 - Vann v. City and County of San Francisco (12/12/2023) 97 Cal.App.5th 1013



Retirement

- Payroll Employee Forfeited Years Of CalPERS Benefits Upon Her No Contest Plea
 - Estrada v. Public Employees' Retirement System (9/21/23) 95 Cal.App.5th 870





- Employee's Service As A Union Officer Was Protected Activity But The District Was Justified In Terminating Her For Numerous Errors
 - Visalia Unified School Dist. v. Public Employment Relations Bd. (1/9/2024) 98 Cal.App.5th 844



- Emergency Did Not Relieve County of Duty To Give Notice And An Opportunity To Bargain
 - Registered Nurses Professional Association and S.E.I.U. Local 521 v. County of Santa Clara (10/17/23) PERB No. 2876-M – JUDICIAL APPEAL PENDING



- Prohibiting Union-Related Insignia On University Vehicles Was Unlawful
 - Teamsters Local 2010 v. Regents of the University of California (10/24/23) PERB No 2880-H



- PERB Finds Retaliation but no Denial of Right to Union Representation
 - State of California (California Correctional Health Care Services) (2/8/24) PERB Dec. No. 2888-S – JUDICIAL APPEAL PENDING



First Amendment



First Amendment

- A City Mayor and Chief of Police Were Not Entitled to Qualified Immunity for Firing Two Officers who Raised Concerns Over the Chief's Job Performance and Alleged Misconduct
 - Noon v. City of Platte Woods (8th Cir. 3/4/24) 94 F.4th 759



First Amendment

 A Police Officer's First Amendment Retaliation Claim Failed When the Alleged Protected Speech was Made in the Context of a Police Department's Internal Grievance Procedures

Massaro v. Fairfax Cnty. (4th Cir. 3/19/24) 95 F.4th 895



Public Records Act



Public Records Act

- Drone Footage is Not Categorically Exempt From Disclosure as "Investigation Records"
- Estimated 1833 Hours (229 Workdays) to Review and Redact the Footage is Insufficient by Itself for Catchall Exemption
 - Castañares v. Superior Court (12/27/2023) 98 Cal.App.5th 295
