# MASS CASUALTY INCIDENT (MCI)

- oln a 20-year review between 2000 and 2019, California had the highest number of active shooter incidents (42).
- oThis is significantly higher than the states with the next three highest number of incidents: Florida (27), Texas (25), and Pennsylvania (21).
- oMost recently, in 2020-2022, California still had the overall highest number of active shooter incidents. Most of the incidents in the last two decades, both nationally and in California, occurred at business locations.

# MONTEREY PARK



- o20 individuals shot
- o11 deceased
- o72-year-old murderer deceased
- Legally purchased weapon that was illegally converted
- Leading theory: domestic violence



# LAW ENFORCEMENT AND POLITICIANS

- Los Angeles Sheriff's Office two public information officers
- oUS Attorney; FBI; ATF; US Marshal; CalOES; District Attorney; Attorney General; Secret Service; LAPD; Alhambra PD; San Gabriel PD
- President; Vice-President; Senators Padilla and Feinstein; Representatives Chu and Schiff; Governor; State Senator; Assemblymembers; LA County Supervisors; Alhambra Mayor



# LESSONS LEARNED

- Local control over the narrative
- Separate emergency operations from politicians/entourage
- oDo not let larger agencies take control, e.g., CPRA responses
- Activate an emergency operations center (EOC) for effective coordination and utilize the entire executive management team
- oBe prepared for personnel investigations of City officials and employees
- Do not ignore your 15 minutes in the spotlight certified Housing Element
- Prepare ahead of time do not delay with a response to community needs

# AFTERMATH: DISCIPLINE AND HEALING

oBe prepared for immediate personnel investigations

- ■This brings out the best & the worst in people
- ■Two investigations thus far

Make sure that the staff & community are cared for

- Community vigil
- Staff acknowledgements



### HOW TO DEAL WITH THE DONATIONS

Monterey Park Victim & Family Support Fund



**Victim and Family Support Fund** 

- More than \$1M donated to Go Fund me sites within six days of the incident
- Do not let other community groups get out in front
- oSet up an endorsed donation fund ASAP in partnership with a foundation (see materials)
- oLet it be a partnership relinquish control. This requires buy-in from the community
- Oversight board & Fund Administrator need to come up with the protocols for distributing funds

# LOCAL REGULATIONS



- Creation of health protection zone
- Support for Gun Violence Restraining Orders (GVROs)
- Adoption of firearms pledge to reduce gun violence
- oGun prohibition on public property
- Secured weapons requirement authorizing the City
   Attorney to criminally prosecute for violations

# HALF MOON BAY

Shooting killed 7 people and critically injured one person.

Shootings occurred at local farms that employed and housed farmworkers and farmworkers' families

Displaced ~20 households and 40 individuals

Accused gunman remains in custody, awaiting trial date





# IMMEDIATE RESPONSE

- Advise elected officials and staff, contact families and victims, create a core support team, procure risk services
- Establish a reunification center to help families find missing individuals, providing translation (Spanish and Mandarin) and cultural support
- Coordinate community vigils and memorial services
- Provide emergency housing (local hotels and AirBnB.org)
- Coordinate with local nonprofits



# LESSONS LEARNED

Maintain local control over the narrative

oSimultaneous disasters happen and require different types of responses

oCities can develop advance preparedness plans



### LESSONS LEARNED

oCities should work closely with community foundations to set up victim compensation funds to ensure equitable distribution and accountability

Coastside Victims Fund raised
 \$254,142 for distribution to 46 victims
 following the distribution protocols set
 by the Oversight Committee



# LESSONS LEARNED

Anticipate claims and potential litigation

o"Never let a serious crisis go to waste" (Rahm Emanuel)

- Expedited approvals in the California Coastal zone
- State and federal funding for housing
- Enhanced code compliance at farmworker housing sites

#### CONEJO VALLEY VICTIMS FUND

- o100% of the funds raised were for
- families who had loved ones taken from them
- those who were physically injured
- those present at the Borderline Bar & Grill
- Ventura County Community Foundation did not charge any Administration Fee
- oThere was an Independent Fiduciary Review by Auditors
- oTranslation services were critical
- oVCCF separately funded mental health services



# FINAL PROTOCOL

- Not easy to give out money
- Ken Feinberg, Special Master of the US Government's Victims Compensation Fund, advised us on a volunteer basis
- oWe based the strategy for disbursements on precedent from other similar tragedies and provided opportunities for feedback on the draft protocol before adopting final guidelines
- o100% of payments were apportioned in accordance with the severity of the injury to the victims
  - families who lost loved ones (70%)
  - those who were physically injured (20%)
  - those present at the Borderline Bar & Grill (10%)

# FINAL PROTOCOL

#### oDetermination of the amounts were based on

- The Balance of the Fund on February 28, 2019
- Completion of the review of all submitted claims
- Review by the Special Oversight Committee and Fund Administrator
- Final approval by the Ventura County Community Foundation

# Timeline

- oDecember 21, 2018: The Draft Final Protocol and Claim Forms began to be disseminated. (www.ConejoValleyVictimsFund.org).
- oJanuary 3, 2019: Two Town Hall meetings.
- of EBRUARY 18, 2019: DEADLINE FOR SUBMISSION OF CLAIM FORMS.
- oFebruary 18 February 27, 2019: All personal meetings requested with Fund Administrator completed.
- oFebruary 18 February 28, 2019: All claims reviewed by the Fund Administrator and recommendations for payments to eligible claimants submitted to the Conejo Valley Victims Fund Special Oversight Committee for independent review and final recommendations to the Board of Directors of VCCF.
- oMarch 1, 2019: Payment Distribution to approved claimants begins on a rolling basis.
- oAfter March 15, 2019: Independent Review by Independent Auditors begins.

# Give An Hour

oGive an Hour was available to offer support to the victims of the Borderline tragedy

- offering no cost mental health services
- providers and staff were available to help those needing assistance with the Victim's Fund Application
- ■Three (3) Victim Assistance Clinics were also provided to assist those who needed help with the Application. Licensed mental health clinicians were on site at the Victim Assistance Clinics to offer support.

# LEARNING THE HARD WAY

olmmediate emergency funding is vital – prepaid visa cards essential

oUnderstand government assistance and victim compensation funds

olmmediate funding to families whose loved ones were taken

Severity of Injury vs Needs Based

oEnsure your partners have staying power as this is extremely challenging work

oLaw enforcement can't share data

oHave meaningful relationships with law enforcement beforehand

oThe difference of an executive order

Language used is different depending on the disaster

# LEARNING THE HARD WAY

- oFind separate funding for mental health and support groups with trauma-informed experts
- oFamilies are complicated
- oFamilies' relationships with money are even more complicated
- Use claim forms that don't require attorneys
- oThe vital role of the Fund Administrator
- oFrauds and scams
- oThe impact of this work on your teams
- oFiduciary oversight as 10,000 gifts come in your door in three weeks
- oSaying "yes" to hundreds of grassroots fundraisers
