
## WHAT IS ORGANIZED RETAIL CRIME?

The large-scale theft of retail merchandise with the intent to resell the items for financial gain (National Retail Federation)

Organized retail theft (ORT) or professional shoplifting, involves two or more people who conspire to steal retail merchandise with the intention of reselling the items at a profit (Investopedia)

Organized Retail Theft is characterized by organized criminal rings that steal property with the intent to sell and distribute, or return stolen merchandise for value (Office of the CA Attorney General)

Nationwide losses in tax revenue due to retail theft = \$15 billion/year\*


\$125.7 billion loss in economic activity

Total Value of Stolen Goods = \$13,780,414,032




