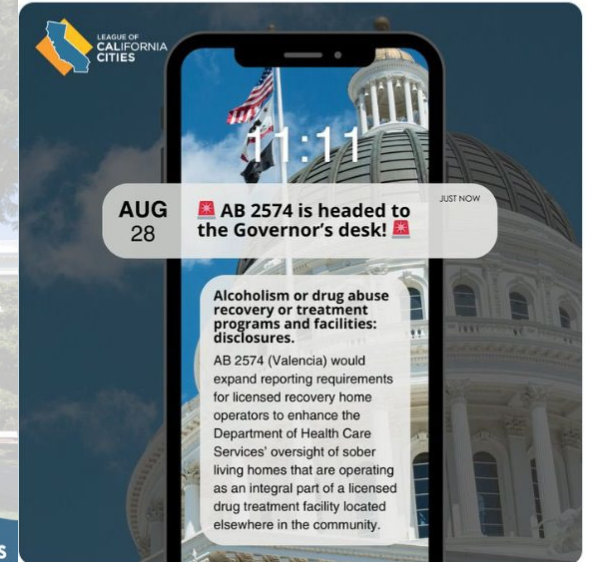

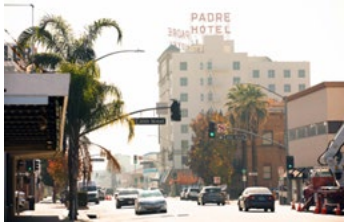

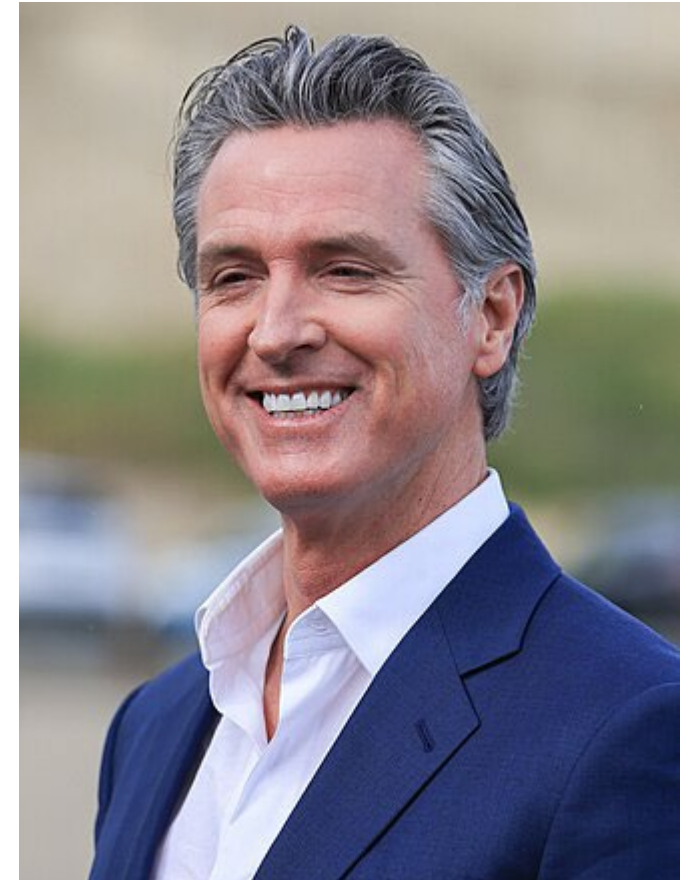

A trip down memory lane...

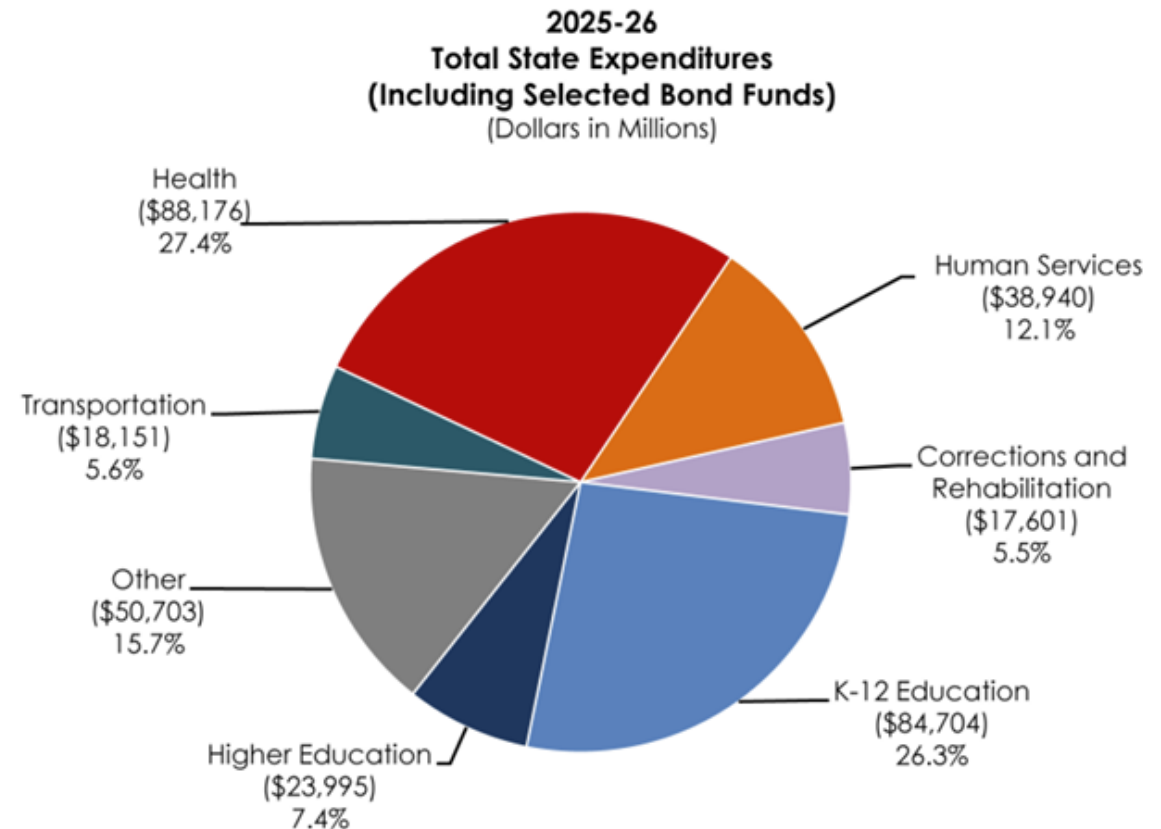
The last few years have been a rollercoaster:

- 2022 – more than a \$90 billion surplus
- 2023 – approximately \$31 billion deficit
- 2024 – nearly a \$47 billion deficit

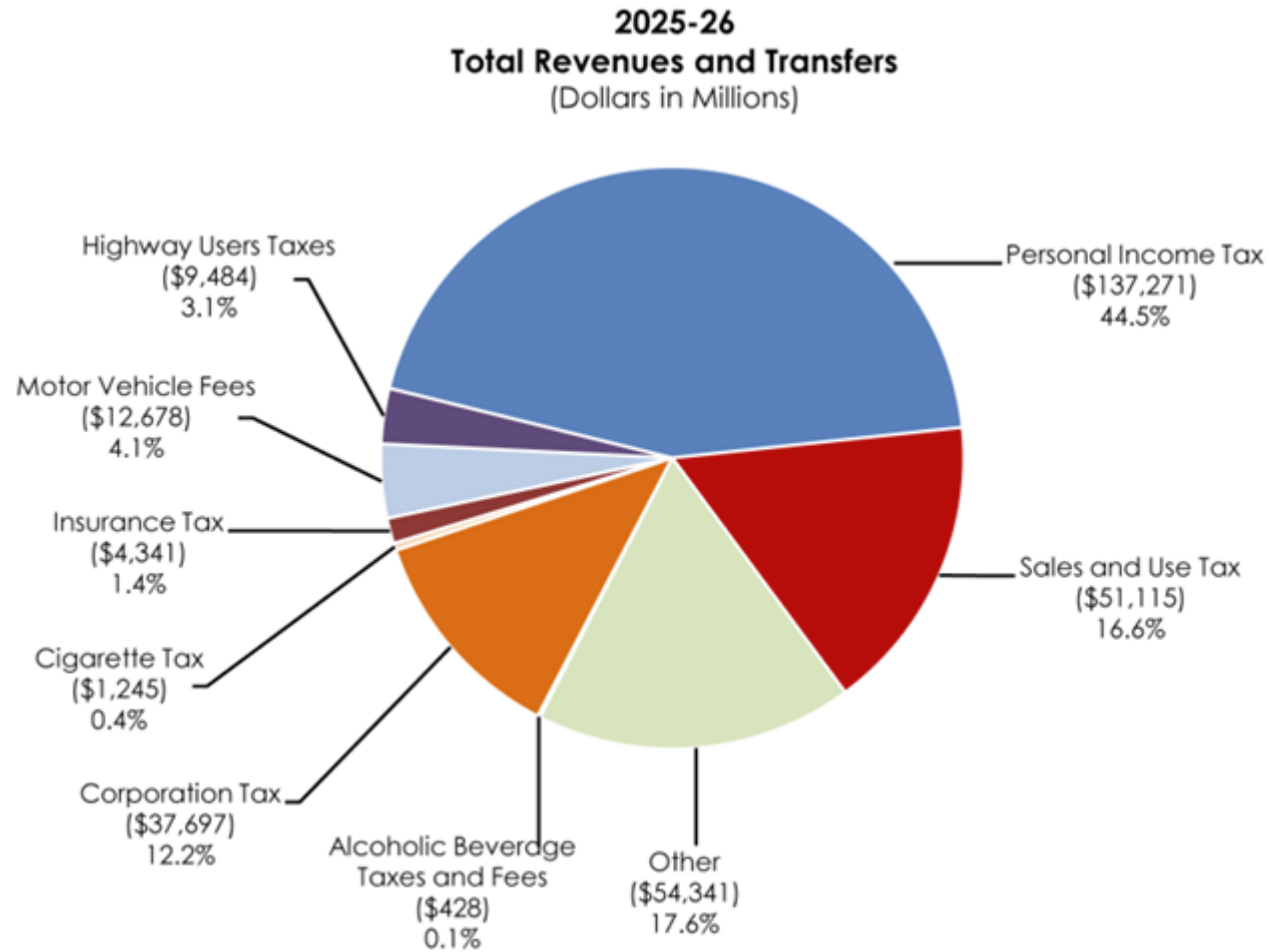


Hot off the press!

- Governor Newsom unveils his FY 2025-26 spending plan
- \$322.3 billion balanced budget
- \$16.9 billion in reserves
- Modest surplus of \$363 million



How are we paying for this?



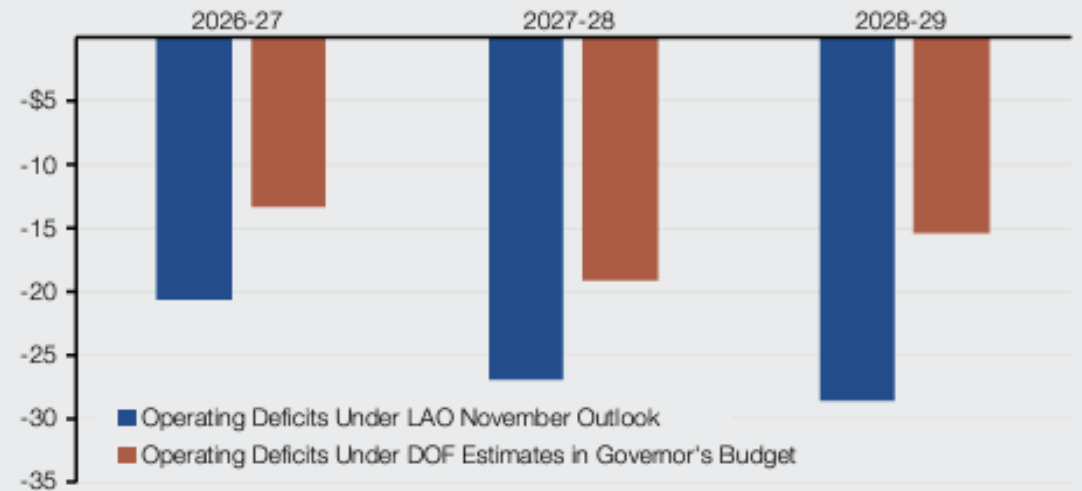
But what does the LAO say?

- The LAO forecasts a \$2 billion deficit for FY 2025-26
- Largely aligned with the Governor
- Recommends maintaining momentum on solving deficits
- Not as rosy of an outlook

Potential Issues in 2025:

- New tax exemptions
- Short-term rentals
- Statewide fiscal reform
- Sales tax rebate agreements/sales and use tax reform

Sales and Use Tax: The Bradley Burns 1%

California Sales and Use Tax Rate Breakdown

State General Fund	3.9375%
County Realignment (<i>Mental Health/Welfare/PS</i>)	1.5625%
City/County General Fund (<i>Bradley-Burns</i>)	1.00%
Countywide Transportation Fund	0.25%
County Public Safety (<i>Prop 172</i>)	0.50%
Total	7.25%

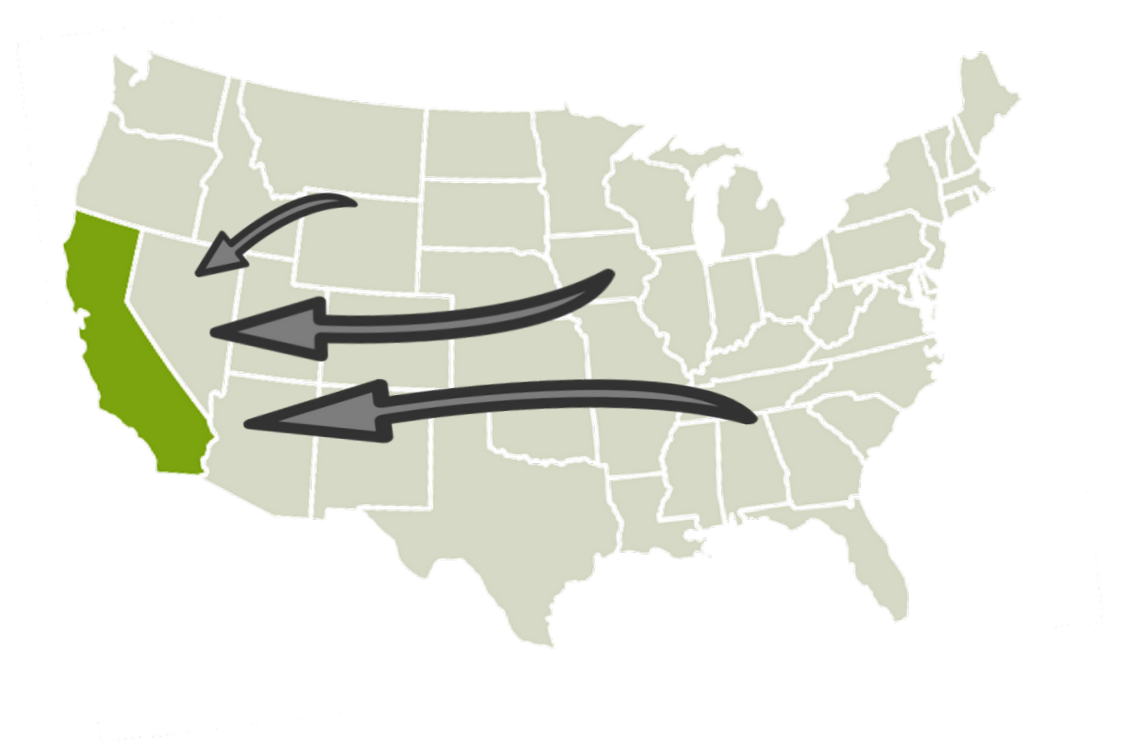
What is Sales Tax?

- Sales tax is imposed on ALL sales of tangible personal property in CA
- Tax only levied once: when purchased or used by the ultimate consumer
 - Retailer buys at wholesale and pays no tax

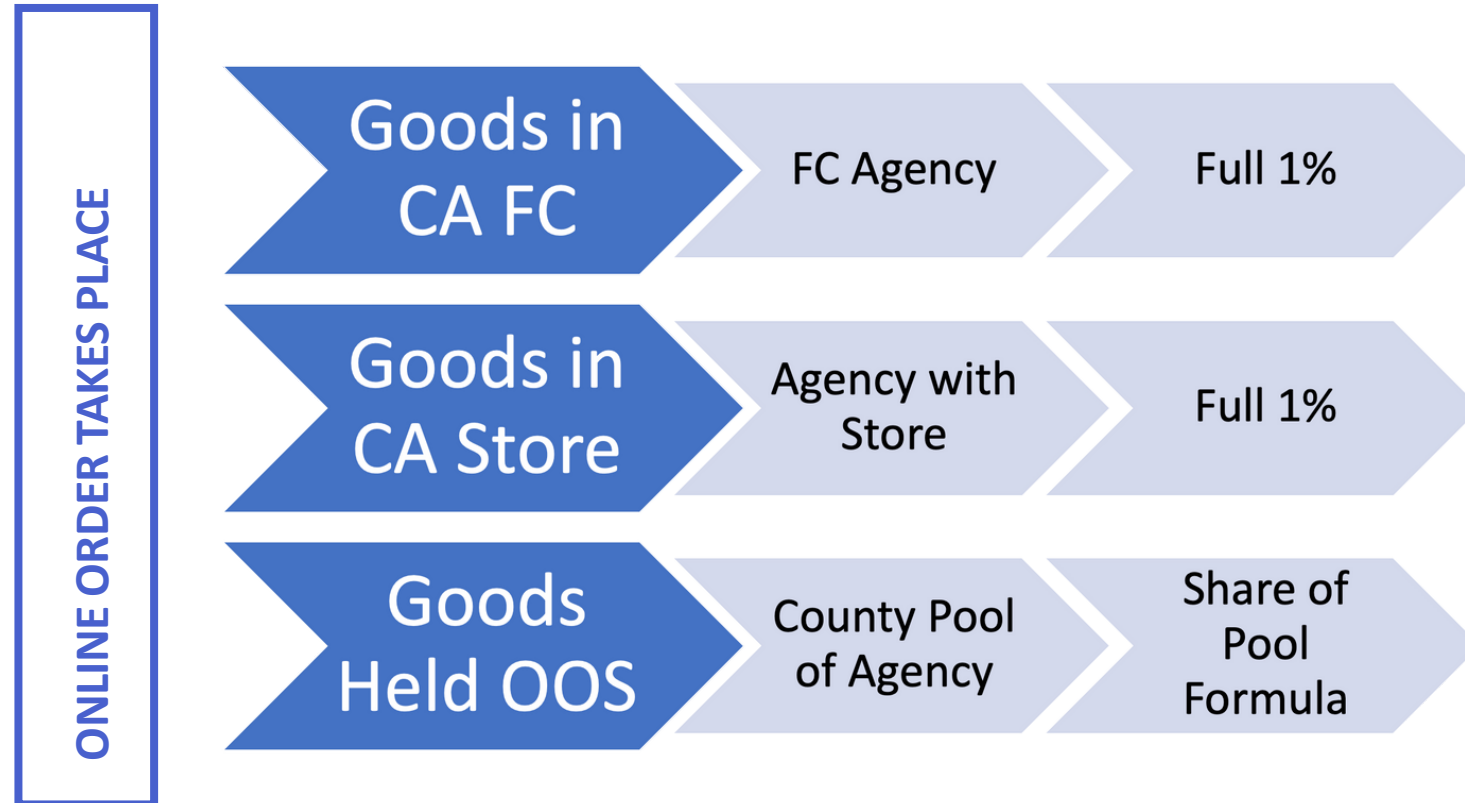


What is Use Tax?

- Charges on goods sold to California customers from out-of-state retailers
- **How is use tax distributed?**
- **First** - allocated into the county pool where the goods were delivered.
 - 58 counties = 58 pools
- **Second** - distributed from each pool to all agencies within a county, using a pro-rata share of sales tax formula

City Managers Sales Tax Working Group

Purpose

To convene a **diverse and representative** group of California city officials dedicated to examining local government sales tax issues and providing recommendations that:

- Equitably benefit California cities
- Further fiscal sustainability
- Strengthen the viability of the sales tax

E-Commerce and Bradley Burns: Recommendations

Equitable split

- Defining Parameters:
 - A 50/50 split of Bradley Burns sales and use tax revenues generated from e-commerce transactions
 - A plus or minus of 10% to allow for flexibility
 - Prospective, revenues from existing sales tax sharing agreements not subject to split
 - Five-year phase-in, post CDTFA implementation
 - County pool use tax dollars redirected to destination city

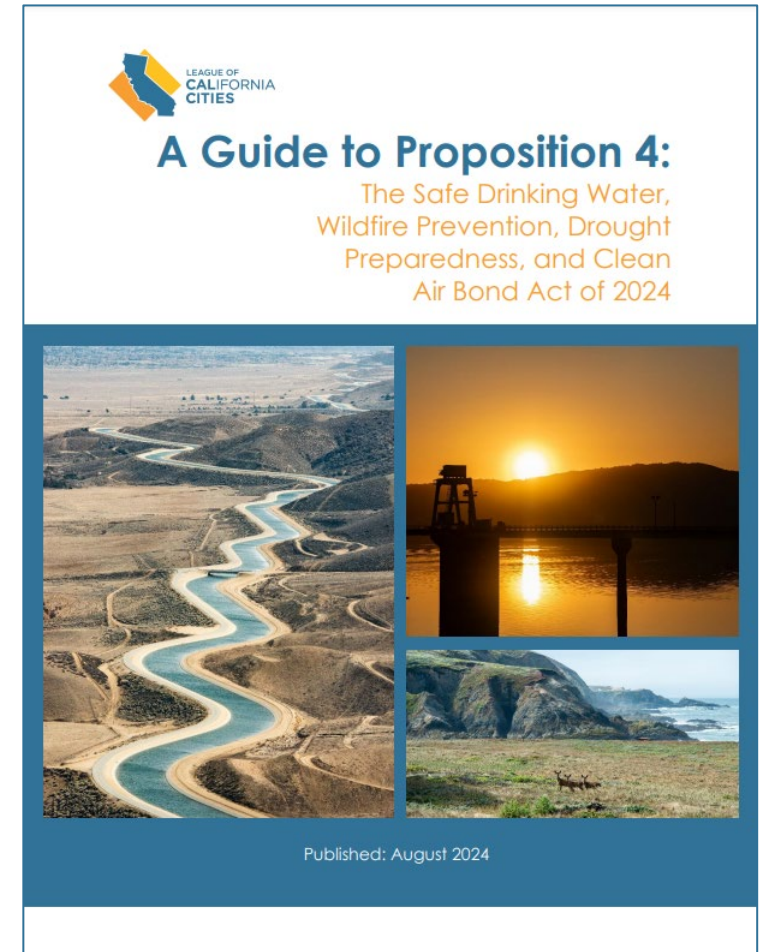

Environmental Quality in the Budget

- 25-26 budget proposes \$2.7B for the first year of a 5-year expenditure plan to implement a \$10B [climate bond](#) ([Proposition 4](#))
- Proposed Budget includes:
 - Safe drinking water, drought, and flood resilience
 - Coastal resilience
 - Biodiversity and nature-based solutions
 - Clean energy
 - Wildfire and forest resilience
 - Outdoor access
 - Extreme heat mitigation
 - Dam infrastructure safety



Environmental Quality

Potential Issues in 2025:

- Disaster preparedness/fire hazard severity zone mapping
- Greenhouse Gas Reduction Fund and Cap-and-Trade Program reauthorization
- Water management legislation
- Coastal legislation
- Clean energy and grid reliability/affordability
- CEQA “reform” legislation
- AB 98 (2024) “warehouse bill” clean up legislation
- Proposition 4 implementation

Transportation, Communications, and Public Works in the Budget

2025-26 budget maintains previous commitments to statewide transportation projects.

Transportation Funding

- Transit Intercity Rail: \$7.7 billion for high priority transit
- Active Transportation: \$100 million to connect communities
- Port Terminals: \$1.2 billion to improve goods movement

Broadband

- The budget continues to delay investments for last-mile projects infrastructure funding

Community Services in the Budget

- **Homelessness:**

- Maintains \$100 million for Encampment Resolution Fund grants
- Creates a new California Housing and Homelessness Agency
- Does not commit to funding round seven of the Homeless Housing, Assistance, and Prevention (HHAP) grant program.
- Reinforces the Governor's commitment to increased accountability

- **Children and child care:**

- Maintains previous funding commitments to implement Universal Transitional Kindergarten fully, expanded after-school and summer programs, and Universal School Meals
- Continues the California State Library Parks Pass program

Potential Issues in 2025:

- Accountability and transparency for state homelessness funding
- Ongoing funding to address homelessness
- Addressing encampments
- Proposition 1 implementation
- Sober living homes and recovery housing
- Seniors and aging
- Community disaster preparedness
- Art and murals

Governance, Transparency, and Labor Relations in the Budget

- **State Employees' Retirement Contributions:**
 - \$6.9 billion (\$3.5 billion General Fund) for the statutorily required annual state contribution to CalPERS for state pension costs in 2024-25
- **Information Technology System Upgrades and Modernizations**
 - Unemployment Insurance Trust Fund Loan Interest
 - EDDNext
 - Division of Workers' Compensation
- **Workforce**
 - California Jobs First (formerly the Community Economic Resilience Fund)
 - Apprenticeship Innovation Fund

Housing, Community, and Economic Development in the Budget

- No new funding to affordable housing programs or restoration of funds after last year's \$1 billion budget cuts to affordable housing
- The Governor released 3 priorities for the year: reducing the cost of housing, enhancing accountability of local governments to meet their housing obligations, and removing barriers to infill housing near transit
- Cal Cities continues to advocate for ongoing funding for affordable housing as budget negotiations continue this spring

- Round 7 RHNA Reforms – HCD Study Response
- Coastal Housing Issues
- Housing Bond

Public Safety in the Budget

The 2025-26 budget proposal includes significant wildfire mitigation and preparedness funding from the climate bond, including:

- **Forest health.** \$82.2 million for projects that improve forest health by significantly reducing fuels
- **Local fire prevention.** \$59.1 million for the Wildfire Prevention Grants Program
- **Wildfire mitigation.** \$9.1 million for the Wildfire Mitigation Program, which offers financial assistance in wildfire-prone areas for cost-effective structure hardening and retrofitting to create fire-resistant homes, as well as defensible space and vegetation management activities

Public Safety in the Budget

- **CalFIRE.** In addition to climate bond investments, an additional \$137.9 million for the continuation and addition of critical major capital projects, including the replacement of various fire stations, unit headquarters, helitack bases, and air attack bases

With the passage of Proposition 36 and a retail theft legislative package in 2024, the Governor's budget proposal does not include any major investments toward reducing retail theft, fentanyl, or other related issues. The Governor's proposed budget does note the impact Proposition 36 will have on the prison and parole populations

- Proposition 36 and Retail Theft Package implementation
- Emergency Preparedness and Response to the Los Angeles County Fires
- Fire Insurance/Home Insurance
- EMS Regulations and implementation
- SB 357 (Wiener, 2024) Clean-Up

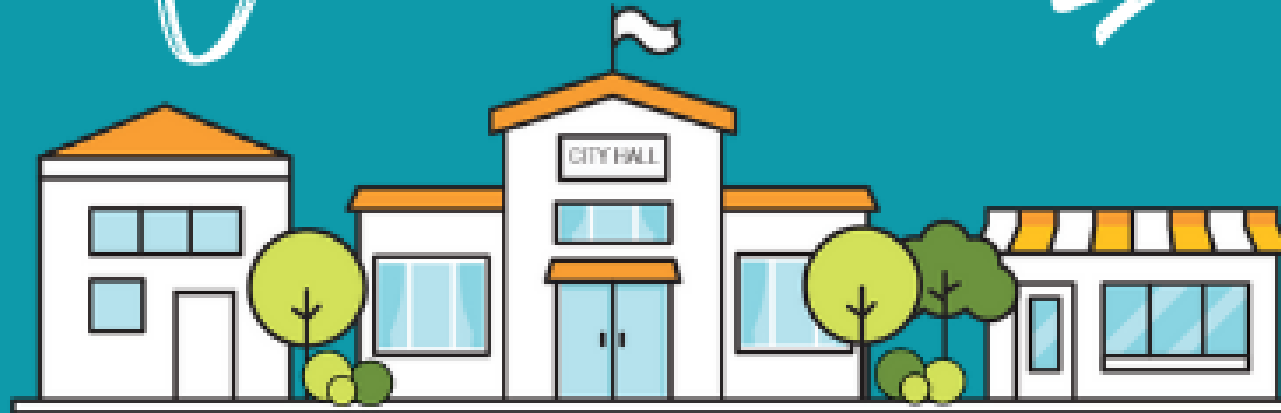
