EXPERIENCE

Cities and public agencies routinely seek Kevin's expertise in navigating the legal and political challenges that arise during the complex planning and entitlement process for large-scale commercial, industrial, and residential development projects.

► Bob Hope Airport Terminal Security Enhancement Project. The Bob Hope Airport Terminal Security Enhancement Project renovated and expanded Terminal A of the passenger terminal building to achieve security screening enhancements and additional fire/emergency access. Kevin advised the Burbank-Glendale-Pasadena Airport Authority on entitlements for the project.

► Bob Hope Airport Property Acquisition Project. The Bob Hope Airport Property Acquisition Project enabled the Burbank-Glendale-Pasadena Airport Authority to provide space for the relocation of airport parking lots, and expansion of aircraft taxiway. Kevin structured and drafted a complex development agreement that enabled the airport authority to obtain necessary land from the City of Burbank for the project and to construct other airport improvements.

The 380-acre Resort development will be the largest proposed commercial and residential project in Monterey County and will feature a four-star 330-room hotel and additional residential units. The 56-acre Main Gate development includes plans for a 500,000 sq. ft. open-air, retail, and entertainment space and a 250-room hotel conference center and spa component. Kevin represented the City of Seaside in connection with CEQA compliance, specific plan and subdivision law, and general plan and zoning amendments for the projects.

► Rancho Cucamonga Victoria Gardens Shopping Center. Kevin represented the City of Rancho Cucamonga in connection with the review of project entitlements and modifications to the residential components of the Victoria Gardens Shopping Center — a 1.3 million sq. ft. open-air mixed-use town center situated on 147 acres and spanning 30 city blocks.
